Please contact the school's Financial Aid Administrator/Director for payment options. While in attendance students may make payments at the institution by cash, check, money order or cashier's check. If an agreement has been made with the institution and payments are permitted after course completion, the student may make payments through TFC by electronic check or debit/credit or at the institution by cash, check, money order or cashier's check. Financial aid recipients understand that monies received on their behalf are applied first to tuition costs.

Any student participating in an approved payment plan must sign a promissory note which discloses the terms of payment.

Tuition payment is an obligation you assumed upon signing your enrollment agreement. Make these payments promptly. Delinquency in payment of tuition will be cause for interruption of training. A student may not receive his/her diploma unless paid in full or a satisfactory agreement has been made with the Director of the academy and the Financial Aid Office. If you are having trouble meeting your financial obligations, you must communicate with the Financial Aid Administrator.

No forms will be completed by the academy enabling students to take the state board examinations until all academic and financial obligations have been fulfilled.

Students who do not complete their program by their contracted graduation date will be subject to over-contract fees.

Over-Contract Fees are as follows:

- Cosmetology \$11 per hour over contracted graduation date.
- Esthiology - \$16 per hour over contracted graduation date.
- Instructor's Course - \$10 per hour over contracted graduation date.
- Barber Program - \$11 per hour over contracted graduation date.
- Nail Technology Program - \$12 per hour over contracted graduation date.
